The GET tokens are sold for Ethereum coins, ETH, as well as other popular and reliable cryptocurrencies like Bitcoin, Bitcoin Cash, Litecoin etc., according to the live exchange rate to dollar. The only requirements for buying tokens are to undergo the KYC procedure and to possess an Ethereum wallet that supports the ERC20 protocol. After the end of the sales period, the distribution of the GET tokens will take place.

10% of the tokens will be generated for the Team

This amount of tokens will be used to cover the internal costs like software development and staff recruitment. The rest will be percentally distributed among the members of the Team.

10% of the tokens will be remain in a Reserve fund

The Reserve Fund will be used to provide rewards to new customers, accelerate the growth of the token ecosystem, and expand the company's operations.
